Transitions a part of life and health care

Three reports on three difficult and different issues that challenge the health system have been released in the last week. They are the Royal Commission reports on aged care and the Victorian mental health system, and the [report by our Youth Health Forum](#).

The last-mentioned focuses on the [transitions young people](#) experience in health care and what we can do to address them. The challenges facing young people in accessing and affording the right care as they move from parental shelter to adulthood are not widely discussed or addressed.

While most young people rated their health as being 'good' or 'excellent', almost half reported high or very high psychological distress. And young people identified multiple barriers to health services, with cost being at the top.

The Youth Health Forum report has injected a fresh perspective into this field of health care with recommendations such as health care concessions for young people and support to navigate the health system.

Life's transitions often pose significant challenges to the health system. Transition considerations thread their way through the subjects of the two Commission reports. Both expose the dramatic deficiencies in the level and quality of care in those settings compared with that we expect in the rest of the health system.

The transition to a different locus of care experienced by the elderly and those with mental illness has left patients often with poorer access to quality services.

Both reports advocate bringing services more within the realm of primary care. As we said in [our media release](#): “We can’t have aged care reform without primary care reform: the need to better care for older Australians is not just about care provided by the institutions themselves.”

On mental health, the [Victorian commission’s recommendations](#) strengthen the cause for expanded community-based and primary care reforms proposed by the [Productivity Commission report](#).

As CHF recommended in our submission to the Productivity Commission, we need to make mental health care more a part of the physical health system.

Transitions are a part of the ups and downs of life — something that we as consumers need to keep in mind in shaping the health we need.

While our changes in health may involve us in a personal transition, we should have services that aim to smooth those transitions.

Apps for My Health Record

If you have a My Health Record and are set up for online access, you have the option of using an approved mobile app.

The apps; Healthi and HealthNow are authorised to view your data in My Health Record. The apps can’t change your data, but will give you secure ‘view only’ access to your information.

They do not permit storage of My Health Record information in the app, or on your phone, and are prohibited from using My Health Record information for secondary purposes – such as passing information to a third party.



Vaping - TGA

The **Therapeutic Goods Administration (TGA)** is conducting a public consultation on a proposed product standard for vaporiser nicotine products, such as nicotine-containing vape liquids, e-liquids and e-juices.

The consultation asks about potential quality and safety requirements for vaporiser nicotine products that have not been approved by the TGA, covering topics such as labelling, packaging and prohibited ingredients. The consultation will close on **31 March 2021**.
