#### What's in the Federal Budget for Health 2023-24?

#### Top ten things consumers want ....

Put consumers at the centre of any healthcare reform Increase access to more bulk billing GPs Provide wraparound care for those who need it most Address rural and remote inequities Integrate care to treat the whole person Greater cooperation between governments Let health professionals operate within full scope Help consumers navigate the health system Build health literacy into preventative health initiatives Promote digital health

#### **Budget context**

- Tight fiscal environment with cost-of-living pressures due to high inflation, rising interest rates, increasing energy costs and lagging wage growth
- Decreased access to bulk billing for people on low incomes
- Pressure from GPs to ease costs of General Practice
- Small (and unexpected) Budget surplus



#### **Health Budget overview**

#### A more compassionate Budget

- Strengthening of Medicare measures eg increasing bulk billing incentives
- Beginning the process of rebuilding and modernising primary care
- Introducing the voluntary registration scheme (MyMedicare) and easier access to telehealth
- Reducing the cost of medicines for people with chronic common illnesses
- Funding for Digital Health and MyHealth Record
- Investment in the health of women and babies
- Support for low-income Australians, First Nations people and those with a chronic condition
- An interim Australian Centre for Disease Control (ACDC) to be established



#### **Stakeholder views**

**ACOSS** disappointed with the low level of increases for Jobseeker and associated income support payments. Welcomed support for single parents and bulk billing increases.

**AMA** welcomes increases in bulk billing incentives and other investments in primary healthcare

AHPA welcomes funding to support allied health to input into My Health Record

**ANMF** welcomes the review of scope of practice for health professionals including nurses and midwives

**Australian Patient Association** welcomes directions of investment in health care but wants to see more detail

**Australian Primary Health Care Nurses** sees the budget as laying the groundwork for structural change and using the nursing workforce in primary to its full potential



#### **Stakeholder views**

**APS** believes workforce measures are a win for psychologists and patients

**COTA** believes the Budget is positive news for older Australians across health and aged care, especially the bulk billing initiatives and improvement to aged care

**FECCA** welcomes the \$2.5m for the Multicultural Health Collaborative but believes more is needed to ensure equitable access to health for people from CALD communities

Medicines Australia welcomes the significant additional investment in primary care

**Mental Health Australia** welcomes investment across health but flags the need for more long-term investment in systemic reform to ensure there is a world class mental health system

**MTAA** welcomes the additional funding across the health system, particularly the investment in primary health care



#### **Stakeholder views**

**National Rural Health Alliance** sees the Budget as a missed opportunity to improve the health of people in rural communities

**NACCHO** the Budget shows the Government is listening to First Nations people with a range of measure that will help to Close the Gap.

**Pharmacy Guild** is unhappy with the changes to dispensing arrangements and not convinced that the package of other measures for community pharmacy will ensure the community is not disadvantaged

**PHAA** believes the \$90m allocated for the forthcoming Australian Centre for Disease Control is a welcome first step, but will need long-term investment

**RACGP** welcomes the increased investment in primary health care.



### **Highlights: Strengthening Medicare**

#### \$6.1 billion overall investment in Medicare

- \$3.5b to triple the bulk billing incentive for people on low income and children (telehealth, in person, MyMedicare)
- \$5.9m for MyMedicare telehealth appointments over 5 years and
- \$98.9m for MyMedicare appointments managing complex conditions over 4 years
- \$19.7m for Dept. Of Health to implement MyMedicare over 4 years
- \$358.5m to set up 8 new Medicare Urgent Care Clinics (currently 50)
- \$77.9m for PHNs to extend After Hours programs for another 2 years
- \$7m for after-hours Health Direct GP helpline





#### **Strengthening Medicare**

#### Focus on improving quality of services

- \$3.5m for the Dept of Health to implement and monitor the helpline (HealthDirect)
- \$586.9m for mental health and suicide prevention in target populations and to extend digital mental health services
- \$40M to develop a Clinical Quality Registries
- \$47.8m Wound care and Chronic Wound Consumables Scheme (over 5 years and \$12.3m per year ongoing)
- \$98.2m in new Medicare rebates for consultations of 60 minutes or longer
- \$118.2m for new and amended MBS items including heart health checks





#### **Priority Populations**

- \$0.9m for a 10-year national action plan for the health and wellbeing of LGBTIQA+ people, and establish an LGBTIQA+ Health Advisory Group
- \$25.4m to establish a Homelessness Support Program
- \$14.8m to establish a PHN Multicultural Access Program (\$15.3m) and for PHNs to support implementation





### **Digital Health**

- \$3.1 million to digital mental health services
- Making telehealth accessible for those with Covid-19
- \$8.7 million to continue capacity of digital mental health services and to maintain the Headto-Health website
- \$111.8 million over 4 years from 2023–24 (and \$24.2 million ongoing) to e-prescription
- \$3.5 billion to increase bulk billing, including telehealth appointments
- \$19.7 million to implement MyMedicare





### **Digital Health**

- \$5.9 million for longer telehealth consultations through the MBS
- \$429.0 million over two years from 2023–24 to modernise My Health Record (MHR)
- \$325.7 million over 4 years from 2023–24 (and approximately \$79.9 million per year ongoing), to establish the Australian Digital Health Agency (ADHA) as an ongoing entity
- \$69.7 million over 4 years from 2023–24 (and \$4.2 million per year ongoing) to respond to the Strengthening Medicare Taskforce Report, and the Independent Review into Medicare Integrity and Compliance to digitise additional health services
- Funding for the Commonwealth's contribution to the Intergovernmental Agreement on National Digital Health





#### **Highlights: Preventative Health**

- 30,000 eligible adult public patients to receive dental treatment
- An Australian Centre for Disease Control
- Therapeutic Goods Administration (TGA) activities aimed at protecting public health e.g. compliance/enforcement, managing shortages, providing information to consumers
- Targeted preventative health initiatives including: research to support womens health, supporting Mens Shed and mens health research, chronic condition prevention and early intervention, and healthy food reforms
- A new national lung cancer screening program that is predicted to prevent over 4,000 deaths
- Boosting efforts to end HIV transmissions in Australia by 2030



# Highlights: Health Service linkage and wraparound

- Connecting frequent hospital users to a general practice to receive comprehensive, multidisciplinary care in the community to reduce hospital re-admission
- PHNs to commission allied health services to improve access to multidisciplinary care for people with chronic conditions in underserviced communities
- MyMedicare to formalise the relationship between patients and their primary care providers to improve patient care and health outcomes





# Highlights: Health Service linkage and wraparound

- Trialing integrated services and joint commissioning across primary health, First Nations health services, disability, aged care, and veterans' care sectors in up to 10 locations; to improve access to primary care.
- Modernising My Health Record (MHR) by creating a new National Repository platform to securely share data across all healthcare settings, improving the sharing of pathology and diagnostic imaging information, and increasing allied health professionals' connection to MHR
- Workforce incentives for primary care practices to provide team-based, patient-centred, high-quality primary care.





### **Highlights: Rural and regional**

- Increasing bulk billing incentives from \$13.15 \$36.65 in rural and remote communities
- Doubling funding for Rural Pharmacy Maintenance Allowance in regional and remote areas (\$79.5 million).
- Royal Flying Doctor Service to provide primary care and aeromedical evacuations to remote communities (\$29.1m over 2 years)





### **Highlights: First Nations People**

- \$141.2m to expand the Tackling Indigenous Smoking program to include vaping
- \$238.5m to address inequity in cancer outcomes for First Nations people by building the capacity and capability of Aboriginal Community Controlled Health Services to support cancer care on the ground and ensure mainstream services are culturally safe and accessible
- \$17.2m to expand the Deadly Choices Program and the Practice Incentives program Indigenous Health Incentive to increase uptake of annual health checks.
- \$1.4m 'Strong Born' awareness campaign for fetal alcohol spectrum disorder (FASD)
- Increase renal services (\$28.2m)





#### **Highlights: Consumer Engagement**

- \$10.5 million to strengthen the capacity of the Consumers Health Forum (CHF)
- \$2.5 million investment will provide seed funding to the Federation of Ethnic Communities Council of Australia (FECCA), to establish the Australian Multicultural Health Collaborative.
- \$8.7 million over 3 years from 2023–24 to establish and operate 2 independent national mental health lived-experience peak bodies to advise on mental health policies and programs and to support lived-experience research
- Culturally and linguistically diverse (CALD) Consumer Engagement in Primary Care Reform \$13 million over 4 years



### **Highlights: Pharmacy and prescriptions**

- Allowing 2 months' worth of certain PBS medicines to be dispensed by pharmacies from 1 September 2023.
- Electronic-prescription delivery infrastructure and services, including mandating the use of eprescribing for high risk and high cost medicines subsidised under the PBS
- Subsidising community pharmacies to administer eligible National Immunisation Program vaccines
- Doubling the Regional Pharmacy Maintenance Allowance to ensure the ongoing viability of pharmacies due to reduced dispensing income
- Funding the Therapeutic Goods Administration to assist medicine sponsors repurpose targeted medicines by expanding approval for their use in Australia.



### **Highlights: Vaping and smoking**

- A public health information campaign to discourage people from taking up smoking and vaping and encouraging people to quit (\$68.3m)
- Expanding programs and health services to support people quitting smoking and vaping (\$29.5m)
- Increasing tobacco tax by 5% every year for three years, making cigarettes more expensive and less attractive, and taxing all tobacco at the same rate
- Targeted education, services and supports for First Nations peoples (\$379.7m)





### Young people

- Mental health
- Access to GPs and bulk billing
- Vaping education and cessation
- Government support payments –Youth Allowance, JobSeeker, StudyAssist, Rent Assistance etc.
- Scholarships and Job placements





#### **Health Professionals Overall**

#### **Doctors**

- Bulk billing (\$3.5b)
- MyMedicare funding for telehealth (\$5.9m) and long appointments (\$98.9m)
- Medicare rebate for long appointments (\$98.2m)
- New and amended Medicare items targeting heart disease (\$118.2m)
- Expand healthcare teams in general practice \$445.1m)

#### Nurses and Nurse Practitioners

 30% increase in Medicare patient rebates and relaxing legislation (\$46.8m)

#### **Pharmacists**

- Amended or new PBS Listings (\$2.2b)
- National Immunisation Program vaccines (\$114.1m)
- Delivering opioid dependency medications (\$377.3m)
- Rural Pharmacy
   Maintenance
   Allowance (\$79.5m)

#### **Allied Health**

 No allied health specific measures announced



### Lowlights: Prevention and COVID

- Limited movement on dental care
- No plan to increase funding on prevention to reach 5 per cent of health budget
- COVID measures largely limited to vaccinations and diagnoses





### Lowlights: Wellbeing and Climate

#### A disappointing lack of focus

- Wellbeing is intrinsically linked with the environment
  - Food availability, temperature, natural disasters
- Despite this, the climate crisis and biodiversity crisis are not well covered
- Environment section talks about trying to push towards renewables but not much substance
- Significant oversights
  - Eg. Total money for transport emission reduction \$20m over 5 years
  - Vehicular emissions have both an immediate and a long term health impact
  - Much more needs to be done
- Greater action on climate and biodiversity should be a health priority
