In the aftermath of the Federal Election, CHF has continued its work in advocating for a more cohesive health system by welcoming the returned government with three main asks: [primary health care reform](#), [a national prevention health strategy](#) and [greater investment in dental health care](#). These were drawn from [Making Health Better](#), our election priorities on which we had several opportunities to advocate during the election campaign.

As mentioned below, during the election campaign the Coalition pledged funding to support CHF's Youth Health Forum (YHF). This is important recognition that youth health has not received the attention it deserves and CHF will ensure that the YHF is actively engaged in mental health and other relevant policy.

To further recognise the importance of the youth consumer voice and the need to support emerging leaders in governance roles, the CHF Board is now seeking expressions of interest from participants in the YHF to join the CHF Board.

Beyond the Emergency: A national study of ambulance responses to men's mental health

Beyond the Emergency is a ground-breaking study of male mental health presentations to ambulance services. This wide-ranging research project – facilitated by Beyond Blue, funded by Movember Foundation, and led by Turning Point and Monash University, in partnership with ambulance services across Australia – includes new data about:

Male self-harm and suicide

The scale and complexity of mental health issues among men in Australia

The need for more mental health training for paramedics

The relationship between alcohol/substance abuse and mental health issues

Perspectives of men affected by these issues

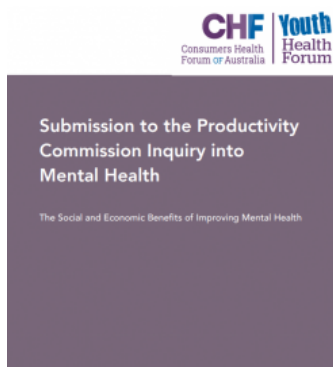


Funding pledged for the Youth Health Forum

In May this year, the Liberal government pledged \$1 million over three years to the Consumers Health Forum (CHF) to support the roll of their Youth Health Forum. CHF welcomed this announcement, which is to support the implementation of the first National Action Plan for the Health of Children and Young People 2020-2030 which will improve children and young people's health by focusing on healthy upbringing, prevention, addressing risky behaviours and childhood mental health.

This action plan identifies the steps needed so our children and young people have the best start in life. The plan will be delivered in partnership with all levels of government as well as health professionals, parents and carers, and young people. It has a particular focus on young indigenous Australians, LGBTI+ young people and those experiencing difficult socioeconomic circumstances in rural and remote regions.
